

# **Shareholder and/or Representative Personal Information Consent Form**

## **(POPIA)**

*MultiAsset Investment Management (pty) LTD, herein referred to as MultiAsset*

The Protection of Personal Information Act (POPIA) applies to the processing of personal information by a responsible party. A responsible party, such as MultiAsset (Pty) Ltd, requires your consent to store, process and use your personal data in terms of your capacity as a representative and/or shareholder of MultiAsset. MultiAsset requires your personal information to comply with legal obligations imposed by the law and regulatory frameworks\*.

**Use of Information:** Your personal information is used where necessary to conduct normal course of business as a shareholder and or representative. We use your personal information for the following purposes:

- to fulfil our contract and obligations with you;
- verify and identify your identity and conduct checks required by regulatory frameworks\*;
- communicate with you;
- comply with legal obligations imposed by the law and regulatory frameworks\*.

**Collection:** We will collect the following (but not limited to) data directly and or/indirectly from you:

- your title, full name, your contact details (email address and telephone/cellphone number);
- that of the shareholder of MultiAsset as well as beneficial owners, trustees etc. thereof as required;
- proof of residential address;
- your date of birth;
- proof of identification, registration, entity verification documents;
- occupation;
- tax number, tax certificates or tax clearance;
- payslip;
- financial information: investment value, source of wealth, source and proof of funds.
- bank account details
- Or as required

For MultiAsset to fulfil their contract with you, it is mandatory that the personal information listed above is provided in to enable MultiAsset to carry out its mandated duties and services. Should you fail to provide MultiAsset with the information, MultiAsset will be forced to terminate the representative contract with you.

**Sharing of Information:** The personal information provided to MultiAsset is kept strictly confidential and MultiAsset will not rent, trade or sell your personal information. MultiAsset will, however, disclose or report personal information if and when required to do so by law or any regulatory framework\*.

**Your rights:** As the 'data subject', you have the right to (after having provided adequate proof of identity):

- access and rectify the information collected;
- object to the processing of personal information;
- request a responsible party to confirm, free of charge, whether or not the responsible party holds personal information about the data subject
- request from a responsible party the record or a description of the personal information about the data subject held by the responsible party, including information about the identity of all third parties, or categories of third parties, who have, or have had, access to the information—
  - i. within a reasonable time;
  - ii. at a prescribed fee, if any;
  - iii. in a reasonable manner and format; and
  - iv. in a form that is generally understandable.
